## **I. QUALIFICATION & EXPERIENCE (exp. as on 31/07/2021):**

**Technical Officer on Contract (Cat. 1):** A First-class Engineering Degree (Full time) in Electronics & Communication with minimum 60% marks in aggregate from any recognized Institution / University with minimum one-year post qualification industrial experience in the field of Embedded, DSP, FPGA, RF Testing & HF / VHF / UHF Radios testing etc. The candidate should be ready to move pan India for equipment, installation and maintenance activities.

**Technical Officer on Contract (Cat. 2):** A First-class Engineering Degree (Full time) in Computer Science / Information Technology (**one post for CSE & one post for IT**) with minimum 60% marks in aggregate from any recognized Institution / University with minimum one-year post qualification industrial experience in LAPP Platform (Linux, Apache, PostgreSQL, PHP).

**Technical Officer on Contract (Cat. 3):** A First-class Engineering Degree (Full time) in Electronics & Communication / Computer Science with minimum 60% marks in aggregate from any recognized Institution / University with minimum one-year post qualification industrial experience in the field of Computer Networking, Java / PHP.

## **II. METHOD OF SELECTION:**

After successful on-line registration, candidates will be shortlisted in order of merit in the ratios of 1:5 based on the marks obtained in their BE/B.Tech. & **One year post qualification relevant experience**. Such candidates will be called for Virtual Interview and recommendations will be made based on performance in the interview & relevant experience. Recommended candidates will be considered for final selection subject to successful completion of document verification.

Date of interview & document verification will be intimated by email in due course of time and candidates are required to attend the Virtual Interview within short notice.

### **III. RESERVATIONS AND RELAXATIONS:**

Reservations & Relaxations for SC/ST/OBC/PwD will be as per Govt. directives.

**Relaxation of Marks:** 1<sup>st</sup> Class is relaxed to 2<sup>nd</sup> Class with 50% marks in aggregate for SC/ST candidates.

**Age Relaxation:** 5 years for SC/ST; 3 years for OBC & 10 more years relaxation for PwD category. The upper age limit is relaxed by 5 years for candidates who had ordinarily been domiciled in the State of Jammu & Kashmir from 01/01/1980 to 31/12/1989.

The candidate can take re-print of his/her registered on-line application form before the last date for on-line registration.
